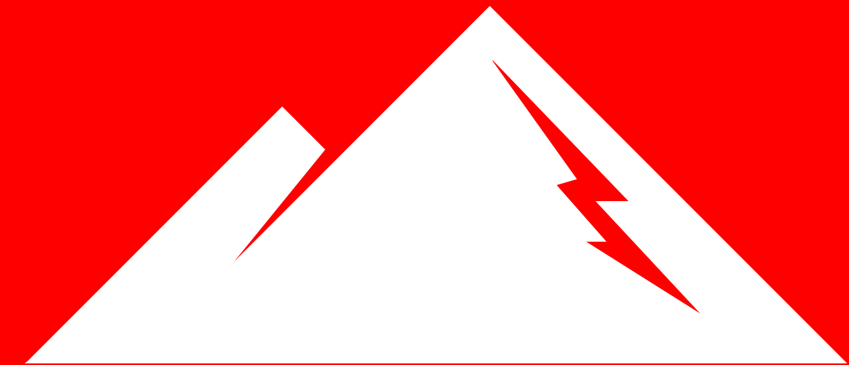

# Day Camp Rules and Info

The Rules and Guidelines for Hilltop Christian Camp are best summarized by the words of Jesus:

*“Love the Lord your God with all your soul and with all your mind...love your neighbor as yourself.”* -

In order to help us love God and love each other, here are a few specific guidelines for Hilltop Christian Camp.

1. Each camper will be supervised by a counselor at all times.
2. For everyone’s safety and benefit-all campers are subject to orders and guidance from any staff member at all times.
3. We will swim everyday unless the weather does not permit. Children will have to take a swim test in order to be allowed to swim in the deep end. The pool will be supervised by several counselors during swim time.
4. Lunch is provided every day. Please make sure to list all food allergies on the other page.
5. A registration sheet will be in the front lobby every morning for attendance purposes, lunch options, and for any special instructions we need. I.e. being picked up early or by a different parent, relative, etc...
6. Boys are not permitted in the girl’s area. Girls are not permitted in the boy’s area.
7. Outside areas including swimming pool, fire circle, sports field, swings etc... are off limits except during supervised activities.
8. The camp phone can only be used when the camper has permission from and is accompanied by their counselor.
- 9. No cell phones**, iPods, laptops, video games, or other electronics are allowed at camp.
