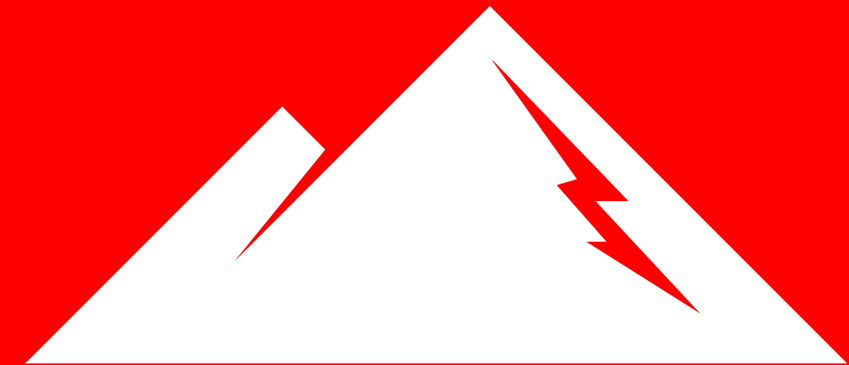

Camp Rules

The Rules and Guidelines for Hilltop Christian Camp are best summarized by the words of Jesus:

“Love the Lord your God with all your soul and with all your mind...love your neighbor as yourself.” -Matt. 22:37-39

In order to help us love God and love each other, here are a few specific guidelines for Hilltop Christian Camp.

Parents and Campers please initial the specified rules *.

1. Be on time to all scheduled activities (meals, devotionals, sports, etc.)
2. Each camper is directly responsible to your counselor.
- *3. For everyone’s safety and benefit-all campers are subject to orders and guidance from any staff member at all times. Parent Initial _____ Camper _____
4. Bunkhouses are to be kept clean. Inspections will be made each morning. Be sure beds are neatly made, floors vacuumed, gear put away orderly, trash around Bunk- house picked up, etc.
- *5. No camper is to be in any vehicle at any time-except for vans during supervised activities. All campers must notify the director(s) if they need to leave camp for any reason. Parent Initial _____ Camper Initial _____
6. Campers are to remain out of the woods unless involved in an organized camp activity.
7. Boys are not permitted in the girl’s area. Girls are not permitted in the boy’s area.
8. Swimming area and fire circle are off limits except during supervised activities.
9. The camp phone can only be used when the camper is accompanied by their counselor.

*** 10. No cell phones,** MP3 players, laptops, game systems, tablets or other electronics are allowed at camp.

11. Respect whatever belongs to someone else. This includes the possessions of everyone at camp, as well as the facilities and equipment that belongs to Hilltop Christian camp.

*12. Please initial to indicate you have read and will adhere to the dress code. Dress code is listed below.

1 No short shorts or skirts. **2** No sleeveless shirts, tank tops or spaghettis straps may be worn. **3** No mid-drifts (belly should not show at anytime). **4** Everyone must be fully clothed when going to and from the shower. This includes wearing shirts with sleeves, and pants/shorts of proper length. No short sleep shorts may be worn back and forth from the shower to the dorm. Towels are not acceptable coverings by themselves. **5** No inappropriate logos or pictures on any item of clothing. (shirts, hats, shorts, pants, pj’s etc...) **6** Everyone must completely cover swim wear (no see through cover-ups) coming and going to the pool (dark shirts and proper length shorts or pants). **7** Shoes must be worn at all times. **8** Pants must be worn at the waist. No underwear should be visible. **9** Flip-flops, slides, crocs, and similar shoes may not be worn in the gym or the field during sports time and during any other running activities.

13. Alcohol, Tobacco, Drugs, Vape Pens, Fireworks, Fire Arms, Knives, or similar items will not be allowed at camp.
